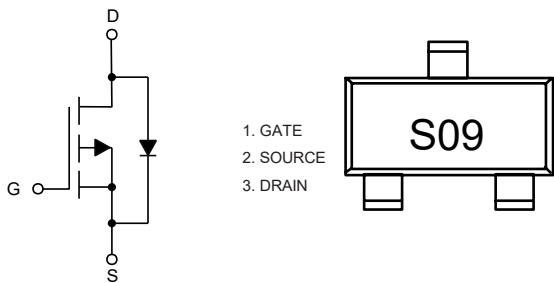

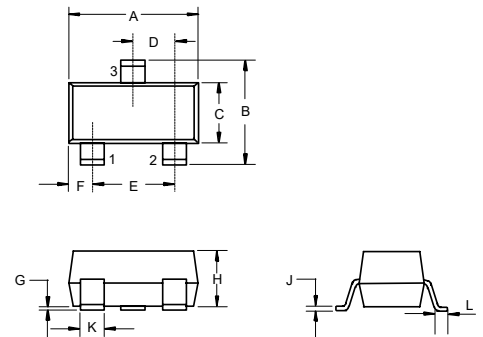

## Internal Structure and Marking Code



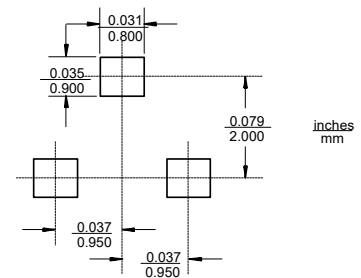

### Suggested Solder Pad Layout

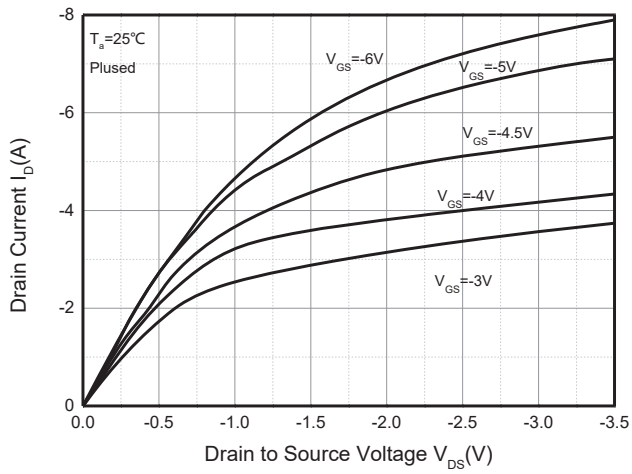

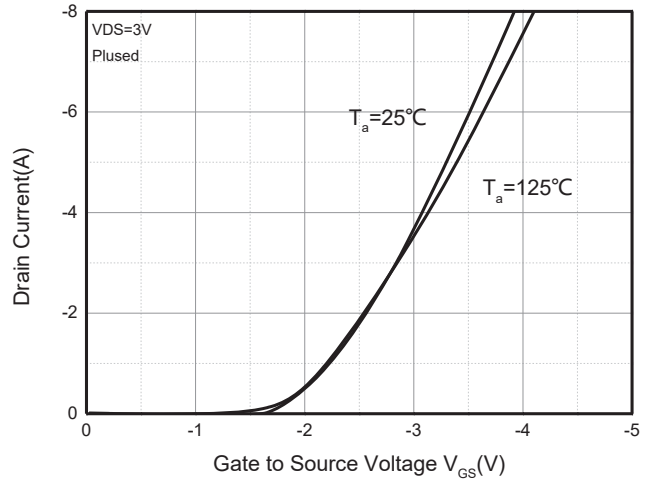

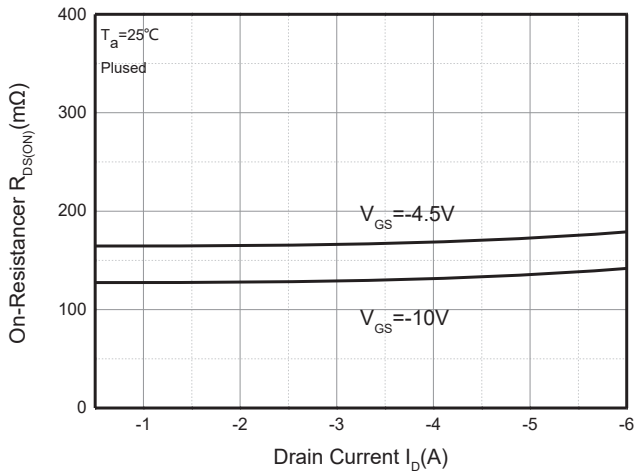
Output Characteristics



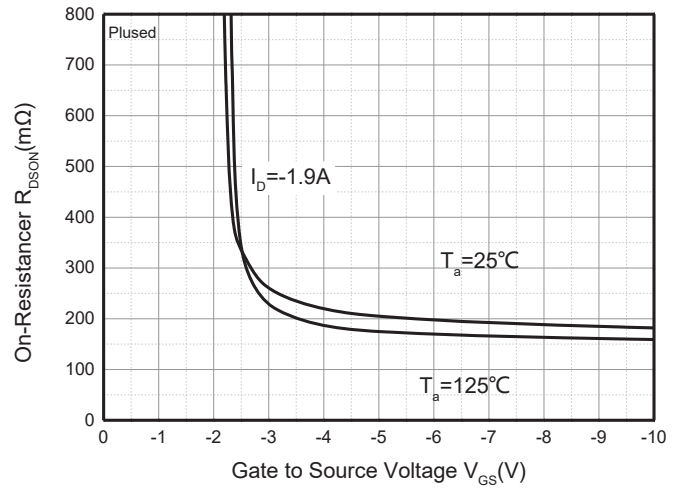
Transfer Characteristics



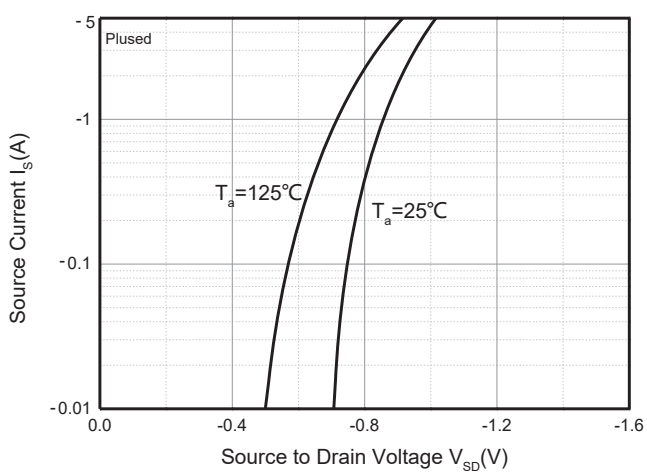
$R_{DS(ON)} - I_D$



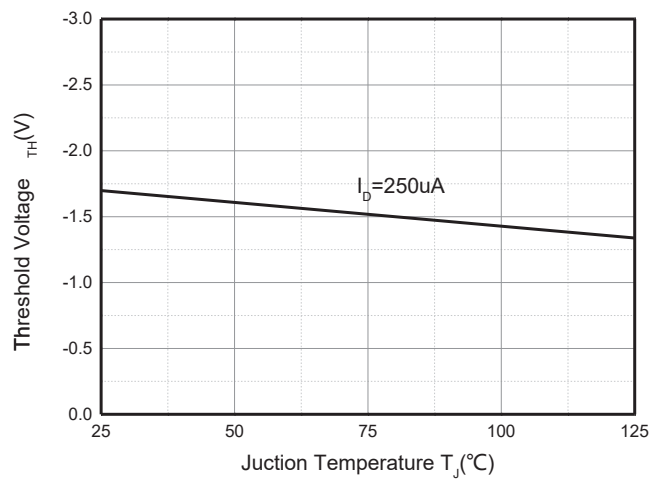
$R_{DS(ON)} - V_{GS}$



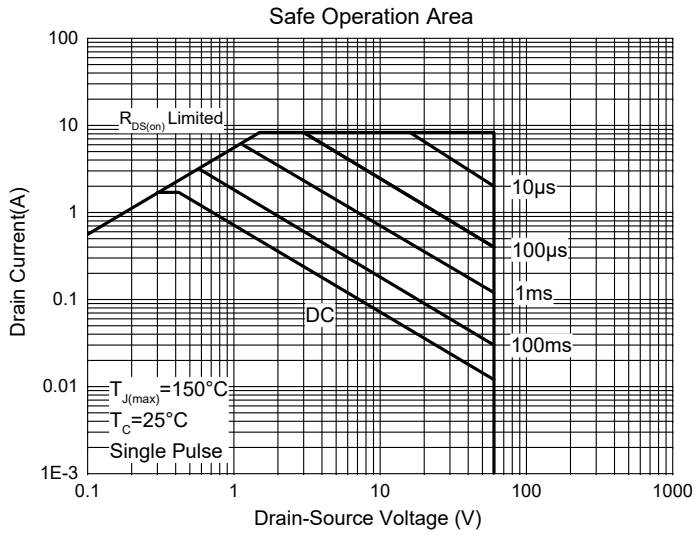
$I_S - V_{SD}$
